

ALLIED PROPERTIES REAL ESTATE INVESTMENT TRUST ANNOUNCES \$75 MILLION PUBLIC EQUITY OFFERING

Toronto, February 22, 2011 -- Allied Properties REIT (TSX:AP.UN) announced today that it has entered into an agreement with a syndicate of underwriters led by Scotia Capital Inc. to issue to the public, on a bought-deal basis, 3,410,000 units from treasury at a price of \$22.00 per unit for gross proceeds of \$75,020,000. Allied has also granted the underwriters an option to purchase up to an additional 511,500 units on the same terms and conditions, exercisable at any time, in whole or in part, for a period of 30 days following the closing of the offering. The issue will be offered in all provinces of Canada. The units being offered have not been, and will not be, registered under the U.S. Securities Act of 1933 and state securities laws. Closing of the offering is expected to occur on or about March 14, 2011, and is subject to regulatory approvals. The REIT intends to use the net proceeds of the offering to fund future acquisitions and for general trust purposes.

"We're pursuing acquisitions in Vancouver, Calgary, Toronto and Montreal," said Michael Emory, President & CEO. "In light of our acquisition targets for 2011, we believe it's prudent to raise some of the equity we'll require ahead of time."
