A person appointed as your proxy holder must be present at the Meeting to vote.

Box 721, Agincourt, Ontario, M1S 0A1, no later than 3:30 p.m. (Toronto time) on Friday, April 28, 2023, or if the Meeting is adjourned, not less than 48 hours (excluding Saturdays, Sundays and holidays) before the time set for any reconvened meeting at which the proxy is to be used.
- (5) Each Unitholder is respectfully requested to exercise the right to vote through any of the voting methods identified above. Unitholders who have voted may still attend the Meeting.
- (6) If any Trust Units of Allied are held jointly by two or more persons, any one of them present in person or by proxy at the Meeting may vote in the absence of the other or others. However, if more than one of them is present in person or by a proxy, they must vote together with respect to the Trust Units held jointly.
- (7) All Unitholders should refer to the accompanying management information circular dated March 21, 2023 for further information regarding the completion and use of this proxy, and other information pertaining to the Meeting.
