- (1) This proxy must be dated and signed by a Unitholder or their attorney duly authorized in writing, or if the Unitholder is a corporation, by the proper officers or directors under its corporate seal, or by an officer or attorney thereof duly authorized. When signing in a fiduciary or representative capacity, please give full title as such.
- (2) **A Unitholder has the right to appoint a person to attend and act for him or her and on his or her behalf at the Meeting other than the persons designated in this form of proxy.** Such right may be exercised by filling in the name of such person in the blank space provided and completing the additional step of registering such proxyholder with our transfer agent, TSX Trust Company ("TSX Trust"), at 1-866-751-6315, or outside North America, at 1-416-682-3860 or online at www.tsxtrust.com/control-number-request, after submitting your form of proxy. Failure to register the proxyholder with TSX Trust will result in the proxyholder not receiving a control number from TSX Trust to participate in the Meeting and such proxyholder will only be able to attend the Meeting as a guest. Guests will be able to attend the Meeting but will not be able to vote. A person appointed as nominee to represent a Unitholder need not be a Unitholder of Allied. A person appointed as a proxyholder must be present at the Meeting to vote.
- (3) If not dated, this proxy shall be deemed to bear the date on which it was mailed by the trustees of Allied.
- (4) To be valid, this proxy must be received by email to proxyvote@tmx.com, by facsimile to 416-607-7964, or by mail to TSX Trust Company, Proxy Department, P.O. Box 721, Agincourt, Ontario, M1S 0A1, no later than 2:00 p.m. (Toronto time) on Friday, May 8, 2026, or if the Meeting is adjourned or postponed, not less than 48 hours (excluding Saturdays, Sundays and holidays) before the time set for any reconvened or postponed meeting at which the proxy is to be used. This deadline may be waived or extended by the Chair of the Meeting at his or her discretion without notice.
- (5) Each Unitholder is respectfully requested to exercise the right to vote through any of the voting methods identified above. Unitholders who have voted may still attend the Meeting.
- (6) If any Trust Units of Allied are held jointly by two or more persons, any one of them present in person or by proxy at the Meeting may vote in the absence of the other or others. However, if more than one of them is present in person or by a proxy, they must vote together with respect to the Trust Units held jointly.
- (7) All Unitholders should refer to the accompanying management information circular dated March 31, 2026, for further information regarding the completion and use of this proxy, and other information pertaining to the Meeting.
